

This application must be accepted by the First Families of Henry County, Ohio Committee.

Give volume and page for book references and include a copy machine, photo, or other facsimile copy of the pertinent pages, and of all published or unpublished records used for proof. Typed, handprinted, or written copies of documents, not certified as 'True Copies', are not acceptable as proof. Published or manuscript material authored by the applicant or his family will not themselves be accepted as proof. Information for on the basic application. If more than two lines are submitted, please include an ancestral chart to show the inter-connections. Only blood lines are acceptable.
