Published or manuscript material authored by the applicant or his family will not themselves be accepted as proof. Information for additional ancestral lines may be included on blank pages, showing the tie-in to the lines on the basic application. If more than two lines are submitted, please include an ancestral chart to show the inter-connections. Only bloodlines are acceptable.
