Any member of the Henry County Genealogical Society who is a direct descendent of an individual who settled in the area now encompassed by Henry County before December 31, 1870 (for Gold membership) and/or December 31, 1885 (for Silver membership), may become a member of THE FIRST FAMILIES OF HENRY COUNTY, OHIO on the acceptance of an application with proof of such descent and the payment of a \$10.00 application fee. This application must be accepted by the First Families of Henry County, Ohio Committee.

Give volume and page number for book references and include a copy machine, photo, or other facsimile copy of the pertinent pages, and of all published or unpublished records used for proof. Typed, handprinted, or written copies of documents, not certified as "True Copies" are not acceptable as proof. Published or manuscript material authored by the applicant or his family will not themselves be accepted as proof. Information for additional ancestral lines may be included on blank pages, showing the tie-in to the lines on the basic application. If more than two lines are submitted, please include an ancestral chart to show the inter-connections. Only bloodlines are acceptable.

2. Donald Deitrick birth certificate shows birth in Henry Co. and parents Henry and Johanna. His obituary lists 6 children, David, Donna, Rita, Theresa, John, Greg.
3. Henry Deitrick baptism record shows his birth and baptism in Henry Co. and parents John and Barbara. Census records 1880-1930 show residence in Henry Co. He married in 1874 to Johanna
4. John B Deitrick baptismal record lists Martin and Catherine as parents. He was a resident of and owned a farm in Henry Co, according to census records from 1850-1880. He died in
5. Henry Co. in 1905. He married Barbara Keible in 1874 in Henry Co.
6. Martin Deitrick settled in Henry Co. by 1850 according to census records. He purchased property according to deed of 1853. Census records indicate he was a resident from 1850-1880. He died in Henry Co. in 1892 according to church burial record.
